If the Mortgage Portfolio Option Holder decides to exercise such Mortgage Portfolio Purchase Option in line with its current expectation, the Notes will be redeemed on their Early Optional Redemption Date in accordance with Condition 7(f) (*Mandatory Redemption under the Mortgage Portfolio Purchase Option or a Market Sale Process*) of the Notes.

The Mortgage Portfolio Option Holder's announcement relates only to the Mortgage Portfolio Option Holder's present expectations (which are subject to change, including withdrawal) and should not be construed as notice to exercise at any time now or in the future any of the rights in respect of such Mortgage Portfolio Purchase Option and of which notice may or may not be given).
